TICKET SOLD PRIOR TO BONUS DEADLINE

All tickets sold by midnight, October 4, 2019, will be eligible for the Bonus draws on October 15, 2019. The draws will take place between 11:00am and noon at the offices of Deloitte LLP located at Purdy's Wharf, Tower II, 1969 Upper Water Street, Suite 1500, Halifax, NS, B3J 3R7.

IF ALL TICKETS ARE SOLD PRIOR TO BONUS DEADLINE

*In the event all tickets are sold by the Bonus deadline of midnight, October 4, 2019, then all draws would take place on October 15, 2019, between 8:30am and 10:00am at the offices of Deloitte LLP located at Purdy's Wharf, Tower II, 1969 Upper Water Street, Suite 1500, Halifax, NS, B3J 3R7.

The top valued prize draw announcements would air on CTV News at 5 on October 16.



IF ALL TICKETS ARE NOT SOLD PRIOR TO THE BONUS DEADLINE BUT ARE SOLD BY THE EARLY BIRD DEADLINE

**In the event all tickets are sold by the Early Bird deadline of midnight, November 1, 2019, then all remaining draws would take place on November 12, 2019, between 8:30am and 10:00am at the offices of Deloitte LLP located at Purdy's Wharf, Tower II, 1969 Upper Water Street, Suite 1500, Halifax, NS, B3J 3R7.

The top valued prize draw announcements would air on CTV News at 5 on November 13.

IF ALL TICKETS ARE NOT SOLD PRIOR TO EARLY BIRD DEADLINE

***In the event tickets remain after the Early Bird deadline, then only the Early Bird draw would be made on November 12, 2019, between 11:00am and noon at the offices of Deloitte LLP. Ticket sales would continue until the final sales deadline of midnight, November 15, 2019.

All remaining draws would take place on November 26, 2019, between 8:30am and 10:00am at the offices of Deloitte LLP located at Purdy's Wharf, Tower II, 1969 Upper Water Street, Suite 1500, Halifax, NS, B3J 3R7. Draws would proceed in order of retail value beginning with the prizes of least retail value.

The top valued prize draw announcements would air on CTV News at 5 on November 27.

Each ticket purchased before the Bonus deadline will be eligible for all 2,460 prizes. Tickets purchased after the Bonus deadline but before the Early Bird ticket sales deadline are eligible for 2,450 draws. Tickets purchased after the Early Bird ticket sales deadline will be eligible for the remaining 2,449 draws.

The Bonus Prize winners, Early Bird winner and the Grand Prize winners will be contacted by phone and letter. All 2,460 winners are contacted by letter to advise of what they have won and how to claim their prize.

HOW DOES THE 50/50 ADD-ON WORK?

The 50/50 Add-On must be ordered in conjunction with your Home Lottery ticket. 50/50 Add-On tickets can be added on to your Home Lottery ticket at the following price points: Single for \$10, five for \$25, or fifteen for \$50. The Add-On purchase must take place at the time of the original order. Add-On orders will not be accepted after your original QEII Home Lottery order date.

The 50/50 Add-On prize value will depend on the nature of sales (the more 50/50 Add-Ons sold, the higher the value of the prize). The winner will take half the pot and the QEII Foundation will take half. Visit QE2HomeLottery.com to watch the pot grow! The minimum payout to the winner is guaranteed to be at least \$250,000.



HOW DOES THE 100 DAYS OF WINNING CASH CALENDAR ADD-ON WORK?

The 100 Days of Winning Cash Calendar Add-On must be ordered in conjunction with your Home Lottery ticket. 100 Days of Winning Cash Calendar tickets can be added on to your Home Lottery ticket at the following price points: Single for \$25, three for \$50, or six for \$75. The Add-On purchase must take place at the time of the original order. Add-On orders will not be accepted after your original QEII Home Lottery order date.

The 100 Days of Winning Cash Calendar consists of 100 cash prizes of \$2,500 to be given out daily starting December 1, 2019 until March 9, 2020.

HOW ARE THE WINNERS NOTIFIED?

All winners will be notified in writing by Deloitte LLP as to what they have won and how to claim their prize(s). It shall be the responsibility of a winner to license and insure vehicles from the time of their ownership. In the event that a winning ticket is held in more than one name, it is the responsibility of the primary ticket holder to share winning information with those parties. Deloitte LLP and the licensee will not enter into any correspondence related to these matters. A complete list of winners will be made available online at QE2HomeLottery.com.

If all tickets are sold by the Bonus deadline, the list of winners will be published October 25, 2019. If tickets remain after the Bonus deadline, and if all tickets are sold by the Early Bird deadline, the list of winners will be published November 22, 2019. If tickets remain after the Early Bird deadline, the list of winners will be published December 6, 2019.

CAN SOMEONE WHO LIVES OUTSIDE OF NOVA SCOTIA OR OVERSEAS BUY A TICKET?

Tickets must be purchased and mailed within the province of Nova Scotia. The lottery is intended for residents of Nova Scotia.

WHAT HAPPENS IF I CANNOT PICK UP MY PRIZE IN PERSON?

Arrangements may be made to have a prize shipped to you freight collect. Arrangements can also be made for someone else to claim your prize with your written approval.

WHAT WILL HAPPEN IS A "BAD" PAYMENT WAS MADE FOR A TICKET (I.E. NSF CHEQUE)?

Only tickets that have been paid for and/or have been verified as paid are eligible to be entered for the respective draw(s). A minimum of one week is allowed between our ticket sales deadline and the draw date(s). This time period allows for all forms of payment to be verified and processed. If for any reason a payment is returned, the ticket will be deemed invalid if a payment cannot be made prior to the draw.



IF I WIN, IS MY TICKET STILL IN FOR OTHER DRAWS?

Yes, after each draw, including the Bonus and Early Bird Draws, the winner is recorded, and the ticket number goes back in for the next draw.

IS MY TICKET PURCHASE TAX DEDUCTIBLE?

No. Ticket purchases are not tax deductible.

DO I HAVE TO TAKE MY PRIZE AS IS OR CAN I JUST TAKE THE CASH?

Prizes must be accepted as awarded. There are no cash substitutes unless otherwise stated. Prizes are transferable.

IF I WIN A HOUSE DO I HAVE TO LIVE IN IT OR CAN I SELL IT?

Once a home is awarded to a winner, they do not have to move in. Any prize can be sold if the winner wishes to do so. The title for a home may be registered in anyone's name.

ARE LOTTERY WINNINGS TAXABLE?

Lottery winnings are considered a windfall and not taxable in Canada. For further details regarding the sales of such goods, please seek professional counsel.

IF I WIN A VACATION PRIZE BUT CANNOT TRAVEL, CAN I JUST TAKE THE CASH?

No, although travel prizes are transferable, so you may give it or sell it to someone else.

HOW LONG DO I HAVE TO CLAIM MY PRIZE?

All prizes must be claimed within 90 days of the applicable draw date. After 90 days, a second draw must be made for any unclaimed prizes as outlined by the Nova Scotia Alcohol and Gaming Authority.

HOW OLD DO YOU HAVE TO BE TO PURCHASE A TICKET?

Purchasers must be at least 19 years of age.

ARE THE PRIZES DONATED?

No, all prizes are purchased by the QE2 Foundation using the tender process.

HOW MUCH WILL THE HOSPITAL MAKE AND HOW WILL IT BE USED?

The projected profit of The Queen Elizabeth II Health Sciences Centre Foundation is approximately \$3 Million. Proceeds will be used to fund a number of important patient care initiatives within the QEII Health Sciences Centre.

WHO IS NOT ELIGIBLE TO PURCHASE A TICKET?

The following, including their spouse and any related or dependent person residing in the same household, are prohibited from purchasing a ticket: The QEII Foundation Board members, Honorary trustees, Foundation staff, board and executive teams of builders contracted to provide real estate prizes to this lottery and any contacted interior designers and partners and employees of Deloitte LLP and its affiliates. Purchasers must be at least 19 years of age. Intended for residents of Nova Scotia.

WHAT DO YOU DO WITH MY PERSONAL INFORMATION THAT YOU COLLECT?

Personal information collected will be used to fulfill ticket orders, provide information on our future lotteries, contact prize winners and publicize the names of prize winners. HOW DOES THE CANADIAN ANTI-SPAM LEGISLATION AFFECT YOUR LOTTERIES?

The primary purpose for sending out Commercial Electronic messages (CEM) is to raise funds for our charity. Under CASL legislation, charities are considered exempt when sending CEMs for this purpose.

WHY DO I HAVE MORE THAN ONE BROCHURE MAILED TO MY HOUSE?

If you are a previous buyer, you will have received a marketing brochure providing an early opportunity to purchase tickets before public advertising begins. Once public advertising begins, a brochure is mailed to all residents of Nova Scotia. If you have received more than one brochure specifically addressed to you, this could be due to different names or different ways of recording the address used when previously purchasing tickets. HOW IS PURCHASING A TICKET DIFFERENT THAN MAKING A DONATION?

Lotteries are a ticket purchase in a game of chance and under the Canada Revenue Agency (CRA) guidelines no tax receipt can be offered. In every facet of our business, we approach fundraising and lottery events in the same manner—to be as cost-effective and as successful as we can possibly be in order to elevate health care for the people in the community we serve.

HOW MUCH MONEY DID THE QEII FOUNDATION RECEIVE FROM THE LOTTERIES IN 2018?

The net revenue from the QEII Foundation lottery programs in 2018 was approximately \$6.3 million. Since 2003, the lotteries have raised over \$73 million in net revenue (proceeds), which has been directed to health care at the QEII Health Sciences Centre.



This money has gone directly to help strengthen care for patients at the QEII, in all 10 buildings across both the Halifax Infirmary and VG sites.

All ticket purchase revenue from QEII Home Lotteries is directed to the QEII Foundation. The QEII Foundation then pays for the expenses associated to running the lotteries, which includes the purchase of grand prize properties and other prizes, marketing, call centre support, insurance and licenses. The QEII Foundation carefully examines balancing the risk and reward of running each lottery in its goal to raise significant funds to advance health care in Nova Scotia. All lottery expenses comply with the rules and regulations established by the governing body, Nova Scotia Alcohol and Gaming Authority.
