### DRAW ORDER

Each ticket purchased before the Bonus deadline will be eligible for all 2,460 prizes. Tickets purchased after the Early Bird ticket sales deadline will be eligible for the remaining 2,449 draws.

### **100 DAYS OF WINNING® CASH CALENDAR™ ADD-ON DRAW DATE**

The draw date for the 100 Days of Winning Cash Calendar Add-On will take place on October 15, November 12 or November 26, between 8:30am and 10:00am, based on the official outcome of Home Lottery ticket sales; (i.e.) Bonus, Early Bird or Final Deadline sellout. All draws will be made at the offices of Deloitte LLP, located at Purdy's Wharf, Tower II, 1969 Upper Water Street, Suite 1500, Halifax, NS, B3J 3R7. Winners will be posted daily beginning December 1, 2019.

Only 100 draws for the 100 Days Of Winning Cash Calendar Add-On winners will be conducted. The approved RNG software will be used to generate the winning



numbers. Only the range of ticket numbers verified as paid for by Deloitte will be eligible for these draws.
