DRAW ORDER AND PROCEDURE

Each ticket purchased before the Bonus deadline will be eligible for all 2,012 prizes. Tickets purchased after the Bonus deadline but before the Early Bird ticket sales deadline are eligible for 2,002 draws. Tickets purchased after the Early Bird ticket sales deadline will be eligible for the remaining 2,001 draws.

*All tickets sold by midnight, April 3, 2020, will be eligible for the Bonus draws on April 14, 2020. The draws will take place between 8:30 am and 10:00 am at the offices of MNP LLP located at 1400 – 1801 Hollis Street, Halifax, NS, B3J 3N4.

The top valued prize draw announcements would air on CTV News at 5 on April 15.

**In the event all tickets are sold by the Early Bird deadline of midnight, May 1, 2020, then all remaining draws would take place on May 12, 2020, between 8:30 am and 10:00 am at the offices of MNP LLP located at 1400 – 1801 Hollis Street, Halifax, NS, B3J 3N4.

The top valued prize draw announcements would air on CTV News at 5 on May 13.

***In the event tickets remain after the Early Bird deadline, then only the Early Bird draw would be made on May 12, 2020, between 11:00 am and noon at the offices of MNP LLP. Ticket sales would continue until the final sales deadline of midnight, May 22, 2020.

All remaining draws would take place on June 2, 2020, between 8:30 am and 10:00 am at the offices of MNP LLP located at 1400 – 1801 Hollis Street, Halifax, NS, B3J 3N4. Draws would proceed in order of retail value beginning with the prizes of least retail value.

Only one draw for the 50/50 Add-On winner will be conducted. The approved RNG software will be used to generate the winning number. Only the range of ticket numbers verified as paid for by MNP will be eligible for this draw.

100 DAYS OF WINNING® CASH CALENDAR™ ADD-ON DRAW DATE

The draw date for the 100 Days of Winning Cash Calendar Add-On will take place on April 14, May 12 or June 2, between 8:30 am and 10:00 am, based on the official outcome of Home Lottery ticket sales; (i.e.) Bonus, Early Bird or Final Deadline sellout. All draws will be made at the offices of MNP LLP located at 1400 – 1801 Hollis Street, Halifax, NS, B3J 3N4. Winners will be posted daily beginning July 1, 2020.

Only 100 draws for the 100 Days of Winning Cash Calendar Add-On winners will be conducted. The approved RNG software will be used to generate the winning numbers. Only the range of ticket numbers verified as paid for by MNP will be eligible for these draws.

PRIZE CLAIM

All winners will be notified in writing by MNP LLP as to what they have won and how to claim their prize(s). It shall be the responsibility of a winner to license and insure vehicles from the time of their ownership. In the event that a winning ticket is held in more than one name, it is the responsibility of the primary ticket holder to share winning information with those parties.
